I consent to medical treatment for athletic related injuries/illnesses by Kiffmann Taekwondo, Inc.. Medical Personnel and/or Hospital Medical Staff. I authorize treatment by such personnel in the event of injury or illness. All medical evaluations completed by Kiffmann Taekwondo, Inc. Medical Personnel for injuries obtained as a result of the Maui Open Taekwondo Championship competitions are considered confidential. Copies of medical injury forms can be requested in writing from the Kiffmann Taekwondo, Inc. Medical Coordinator by the injured competitor, or parent of a minor competitor at the time of injury, or requested in writing following a competition. The original injury report form will remain on file in Kiffmann Taekwondo, inc. Office. No information about an individual competitor will be released without that competitors' permission. Information pertaining to injury data without using a competitor's name will be made available to the Medical Director, the Medical Coordinator or their assistants for the purposes of injury research or recommendations for safety rule changes. A competitors name and injury will only be released in cases pertaining to head injuries requiring the competitor to not compete for 30 days. This information will be released to the Medical Director, Medical Coordinator, Referee Chairperson, Tournament Committee Chairman, Events Director, Executive Director and/or executive committee for purposes of enforcing the 30-day rule in compliance with WTF rules. In consideration of your acceptance of my entry or that of the minor child, I do hereby, for myself of the minor child, my heirs, executors, and administrators waive, release, discharge, covenant not to sue, and agree to indemnify and save and hold harmless any and all rights and claims for damages which I may have or may accrue to me against Kiffmann Taekwondo, Inc, the Maui Open Taekwondo Championship, its organizing committee, the County of Maui, Parks&Recreation, and all members of the Maui Open Taekwondo Championship, or their respective officers, committees, medical committee, agents, representatives, successors, sponsors, advertisers, volunteers, owners and lesser or premises on which the event takes place, assignees and against any competitor for any and all damages which may be sustained by me or the minor child, in connection with my association with or entry in the Maui Open Taekwondo Championship, or which may arise out of traveling to, participating in, and returning from the Maui Open Taekwondo Championship. I understand that all entry fees are nonrefundable. I understand the nature of Kiffmann Taekwondo, Inc. activities and believe that my experience and capabilities, or that of the minor child, to be qualified to participate in the Maui Open Taekwondo Championship. I understand that Kiffmann Taekwondo, Inc. activities involve risks and dangers of serious bodily injury, including permanent disability, paralysis and death. These risks and dangers may be caused by myself or the minor child's own actions, or inactions, and/or the actions or inactions of others participating in the Maui Open Taekwondo Championship. I have read this agreement, fully understand it's terms, understand that I or the minor child have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by the law and agree that if any portion of this agreement is held to be invalid that the balance, notwithstanding, shall continue in full force and effect.
